Tony has the burn trailer and is currently installing doors and an adapter box, he will also get a few spare tires for the trailer. This work will cost around \$1,000. Tony will give the invoice to Bob Mahoney Jr. when done for approval.

Bob Mahoney Jr. has several 1 ½" fire hoses that we can use for burns if needed.

Painting of the trailer with a high temp paint to withstand the burns was also a topic of discussion. The work could take place in the spring of 2015 or 2016. A NTE quote of \$3,000 was obtained.

A location needs to be found to house the burn trailer when not in use. Les with Bullseye said it can be stored at his office and Tom with Howells said he could store it as well, except in the winter months.
